EMPOWERING OUR WIDOWS A TRAINING PROGRAM CURRICULUM

EXECUTIVE SUMMARY

<u>Health Issue</u>: There are approximately 250 million women around the world who have been widowed (Adebayo, 2020). In many cultures, there are traditions and practices related to widowhood. In several African countries in particular, many communities practice widow cleansing rituals and there are traditions regarding inheritance of widows.

Our team recognizes and appreciates that cultural traditions around the world are best understood by those who practice them, and should be viewed with an open mind and mindset of cultural humility. However, studies conducted about these rituals, as well as personal anecdotes from women who have experienced these rituals, have demonstrated the harmful effects of some of these traditions. Rituals may include: (i) Having to engage in unprotected sexual intercourse with a male relative of the deceased husband; (ii) Shaving of all body hair; (iii) Forced bathing in the presence of community members; (iv) Seclusion or isolation, and many others (Akinbi, 2015).

Many of the communities in this region share the belief that these rituals protect the family and community from negative events that may occur due to the deceased husband's spirit – in order to appease this spirit, the recently widowed woman is forced or coerced into practicing these rituals. If she chooses not to participate, she may lose economic support for herself and her children, and may be ostracized from her family or community (Akinbi, 2015).

A qualitative study conducted in the Luo community in Kenya found that widows are incentivized to engage in sexual intercourse with an "inheritor" who will then provide some support to the woman in terms of assisting with maintaining her home, such as conducting repairs in the house (Perry, 2014). However, the belief in this community (like others) is that unprotected sex is a requirement for success of the ritual – this in turn has led to greater rates of HIV transmission for these women. The women are also not always in a position to negotiate condom use due to power imbalances. A quantitative study conducted in Mozambique also found that 61% of the 359 respondents believed that the widow cleansing rituals need to evolve to address high HIV transmission rates due to the rituals, and to better respect the human rights of the women involved (VeraCruz, 2018).

In several African countries, interventions exist which address key issues, including (i) violence against women, (ii) economic empowerment of women, and (iii) HIV prevention. Campaigns to address these social norms have also been conducted. However, we were unable to find a curriculum for a training program that brings together key stakeholders from multiple disciplines to address this issue through inter-professional collaboration. The curriculum below therefore addresses this gap.

<u>Where</u>: This training program will be conducted in a city in Nigeria; participants will be members of communities where these rituals are prevalent, specifically in the Yoruba and Igbos communities. However, the training program can be adapted for other African countries, which have documented similarities in rituals and beliefs, such as Kenya (Luo community) and Mozambique (Sofala, Manica and Tete provinces).

<u>Who</u>: Training trainees will be multidisciplinary community leaders, including lawmakers, religious leaders, advocacy group leaders and health workers.

What: This curriculum is for a 5-day training program on widow cleansing rituals. The program would ideally be followed by monthly gatherings, organized by trainees, which would consist of educational events covering topics of interest expressed by trainees. These follow-up gatherings would also provide an avenue for sustained collaboration on addressing this issue, thereby achieving long-term goals.

<u>When</u>: As the trainees are all professionals who work full-time, our training program will take place every Saturday, over the course of 5 weeks. As Fridays and Sundays are significant for certain religions, we have planned for this training to take place on Saturdays. The sessions will commence at 9 am, include a lunch break, and conclude at 4 pm. We will implement this training during a 5 week period in which there are no major religious observances or festivals.

OVERVIEW OF TRAINING PROGRAM

Goals: Long-term goals for this training program, with a timeline of 10 years, include (i) changing social norms surrounding widow cleansing rituals, (ii) improved economic empowerment of women, (iii) decreased abuse against widows and (iv) implementation and enforcement of laws and policies against harmful widow cleansing rituals. Short-term goals are (i) increased awareness of this issue, (ii) development of an interdisciplinary team to address this issue in various sectors, (iii) establishment of a system for future collaboration between stakeholders following conclusion of the training, and (iv) increase in will-creation and preparedness for family support among men in the community.

<u>Trainers</u>: An inter-professional team consisting of two alums from the Columbia University, Mailman School of Public Health, in collaboration with three local leaders from the communities of interest.

<u>Trainees</u>: 2 individuals from each of the following categories (twelve trainees total): (i) Lawyers, (ii) Traditional religious leaders, (iii) Ministers/Priests from local churches, (iv) Imams from local mosques, (v) Advocacy group leaders and (vi) Health professionals (including psychologists, psychiatrists, nurses, or physicians).

Adult education methods and strategies: This training curriculum will ensure that sessions and activities build on trainee's existing knowledge and skill sets. Activities will incorporate facilitated discussions, case-studies, role-play and so on, which will allow trainees to learn actively and use their own expertise. Although there will be some facilitation, these activities will encourage independent learning and ownership of the material. Trainees will be reminded that they all play an important role in addressing this issue, which will motivate participation. Appendix A provides 2 detailed session plans which demonstrate how these methods and strategies have been applied.

TRAINING PROGRAM OBJECTIVES

By the end of the training program, trainees will be able to:

- 1. Recognize 3 mental health effects of widow cleansing rituals[^];
- 2. Recognize 3 sexual health effects of widow cleansing rituals[^];
- 3. Explain the importance of will-writing for economic empowerment of women[^];
- 4. Support efforts to communicate with community members about this issue*;
- 5. Apply knowledge gained from training to engage colleagues in discussion about this issue*;
- 6. Design a strategy for future collaboration to address this issue+; and
- 7. Facilitate collaboration between various stakeholders on this issue*.

SESSION STRUCTURE

As seen in the curriculum overview above, the training program consists of five sessions. The general structure of each session is as follows. The day-long session commences with team building activities and review of material that was assigned prior to the session. This is followed by an introduction to new material on the topic of interest. Following an hour-long lunch break, the remainder of the session will consist of interactive activities, an introduction to what will take place in the following session, and finally a survey conducted as part of the evaluation. Appendix A below provides a detailed plan for Sessions 1 and 2, which demonstrates the mix of push and pull strategies, as well as other adult education methods.

EVALUATION PLAN

Our plan for evaluating this curriculum consists of strategies and tools to address the four levels of Kirkpatrick's hierarchy. Firstly, to measure "reaction," a satisfaction survey will be completed by trainees after every session (refer to Appendix B1 for this tool). To measure "learning," pre and post-tests will be conducted to gauge knowledge at the beginning of the first session versus knowledge at the conclusion of session five. These tests will be anonymous and unmatched – therefore an aggregate will be used. This is in order to utilize paper surveys which may be more feasible.

"Performance" will be measured by in two ways. Firstly, a brainstorming session will take place during session 5 in which trainees will prepare and present on strategies to collaboratively address the issue of widow cleansing rituals – an observation of this activity, alongside qualitative feedback, will be utilized. Secondly, a follow-up interview will take place 3 months after the training program has ended, to measure intermediate-term outcomes.

Population-level surveys in communities of interest will be conducted 1 year following the training program to measure "impact." Finally, the trainers will complete a checklist during each session to evaluate fidelity as part of a process evaluation.

BUDGET

The budget for the Empowering Our Widows training was estimated to be around \$104,575, for an average of about \$8,700 per trainee. This budget was made based on other similar programs previously implemented in this region, and based on a cost analysis conducted prior to arriving in Nigeria. Our budget was broken down into 5 categories: (i) Facilitators, (ii) Materials, Equipment and Facilities, (iii) Participants, (iv) Miscellaneous, and (v) Evaluation. Under our budget for facilitators, we allocated funding towards paying for the salaries of two full-time Columbia University facilitators, as well as the salaries of three part-time local Nigeria representatives. Aside from the their salaries, we also allocated funding towards their food, travel, and accommodations as needed.

Given that part of our curriculum included three panelists, we also included a small honoraria award for each participant. The training team estimated that about \$2,000 would be spent on program training materials and facilities, and about \$1,875 would be spend on participant's travel, food, and refreshments. To facilitate communication for Columbia University facilitators in Nigeria, money was allocated for the purchase of cellular sim-cards that would allow them to connect with trainees and program representatives as needed. \$300 was set towards a closing ceremony for trainees to celebrate their accomplishment. Lastly, our budget included \$8,250 for program evaluation, which would pay for an external evaluator's stipend, travel, and accommodations in Nigeria, as well as for the cost of disseminating the results of their findings.

LIMITATIONS AND CHALLENGES

Although a review of the literature was conducted, we believe that other interventions could already exist in several of these countries that are not easily found through online searches. Perhaps curricula already exist for training programs that have simply not been published, and therefore we were unable to find these in our research.

This curriculum is rooted in evidence and theory, however a vital component missing in the creation of this curriculum is input from members of the communities in which these traditions and rituals are practiced. These training curriculum would be strengthened greatly by involving key stakeholders from the communities of interest in all phases of designing and implementing this curriculum. This would also be the most equitable way in which to engage with these communities. Due to the scope of this assignment, it was impossible to engage with these key stakeholders.
